- 11) The rate of tuition and other fees shall not be changed without the prior permission of the Board.

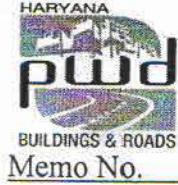




